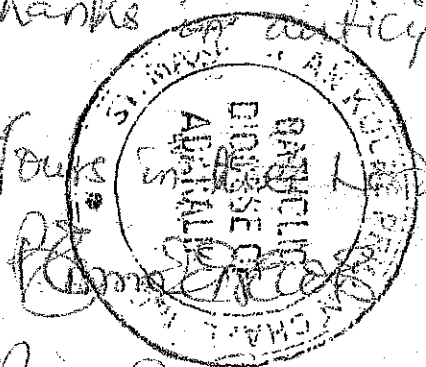

We are mostly grateful for your immeasurable support in all ramifications. Your support since our election and enthronement as Bishop of Ngbo Diocese (Anglican Communion) and other programs (Synod) has gone a long way in helping us to fulfill our mandate in the Diocese. We also appreciate your effort and magnanimity towards our schools (Anglican Schools) as a whole, particularly in the area of providing portable drinking water and helping the less privilege people in various villages at various communities and Ebonyi State at large. We pray that our good Lord will continue to take you to greater heights in Jesus name, Amen.

As "Oliver Twist", we write to appeal for your intervention in respect of the above subject. It has been a great concern to me since our enthronement that my village (Agalagu Amagu in Ikwo L.G.A) don't have good drinking water because their source of water supply only depends on well, local streams and ponds which do not last throughout seasons of the year.

However, I write this application to your office requesting for drilling of a borehole in my village for the following reasons:

- High rate of difficulties in search of water in the area has brought about crippling of the human activities like lateness of students to school, poor farm produce, and sometimes absent in other duties of obligations, for struggling of water with other communities which sometimes bring about fighting and quarreling.
- Scarcity of drinkable and ordinary useable water for human activities; like washing of clothes, cooking, fermentation of our local foods, drinking etc.
- Contamination of water borne diseases as Guinea-worm, Dysentery, Diarrhoea, typhoid fever and Schistosomiasis etc has been a long lasted problem in my village and this has kept us on drinking contaminated water only available to us.

It is on this ground that I appeal to you to help us with a borehole and we appeal if you consider my village (Agalagu Amagu, Ikwo L.G.A) in the next phase of this developmental stride and humanitarian work in order to reduce stress and eradicate various diseases in my village.

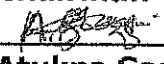
- (a) To get water members of the village travels kilometers away in other to fetch water.

With utmost sincerity, we the entire members of Ndiagu mkpuma Amaeffia of the above mentioned address wish to apply for the borehole drilling within our environment.

History background of Ndiagu Mkpuma Village

Ndiagumkpuma Village Amaeffia Ngbo is one of the first major villages created in Ameku, bounded with Ndiagu-Obu, Ntezi and Ojiegbe Communities with an estimated population of about 3000 people they mostly practiced agriculture as their major source of living.

Since the existence of Ndiagumkpuma one of the major problems obstructing them is the water scarcity and non-availability of clean water for domestic and other needs and regular consumption of unclean water which has really caused serious setback in the village. However, the only available source of water in the village is the Ochiaja unclean water pond with the distance of about 28kms away from Ndiagumkpuma village.

This problem of scarcity of water has caused great suffering and decrease in the population of Ndiagumkpuma village as listed below:

Steady increase in the spread of air born diseases and bacterial infections such as guinea worm, cholera, diarrhea, tuberculosis etc. has been killing Ndiagumkpuma people on yearly bases.

Underserved suffering among pregnant women during and after pregnancy led to maternal health and child mortality as they cannot work to a far distance in search for water and also bacterial infection caused by consumption of unclean water during and after pregnancy.

Scarcity of water in Ndiagumkpuma has also contributed to school dropout among school children as they find it very difficult to wake-up

on time to a such far place in search for water before going to school on daily bases.

Finally special and elderly persons cannot walk in search for water and many have been seriously injured in the process of struggling to fetch pond per turn.

We promise to provide all expected hygiene, guide and maintain the proposed borehole properly if given to us and to carry serious campaign against open defecation among our people.

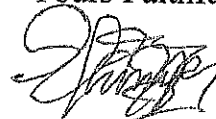
A Request For Pipe Borne Water

Cases of water born diseases like cholera, typhoid, dysentery, diarrhea etc, is rampant in the village.

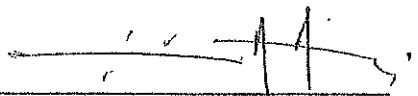
Our sources of water supply are mainly rainwater, well water, pond and stream water.

The struggle to get water from these sources mostly in dry season is high, such that some times it leads to fighting which result to injuries.

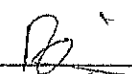
